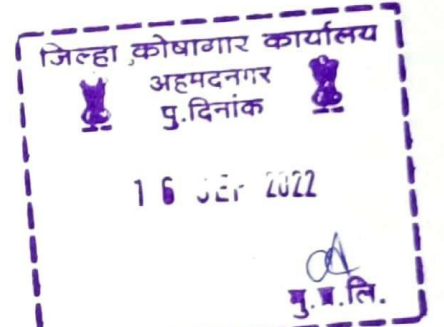

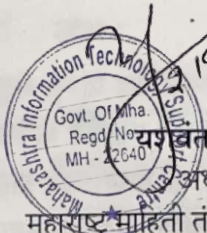

SHODH ADVANTECH LLP, having its works office at C-36/2, MIDC, Chikhalthana, Aurangabad Pin - 431 006 (Second Party), and represented herein by its Founder Partner and Chief Resource Technical Operations, **Ms. Rajani Mudkavi** (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- A) First Party is a Higher Educational Institution named:
 - (i) **New Arts, Commerce & Science College, Shevgaon Dist- Ahmednagar MH Pin - 414502**
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.
- E) **SHODH ADVANTECH LLP,C-36/2, Chikhalthana MIDC, Aurangabad Pin - 431 006**, the Second Party is engaged in Business, Manufacturing, Skill Development, Education and R&D Services in the fields of – **Academics** and related fields.
- F) **SHODH ADVANTECH LLP, Opposite IGTR, near Universal High School, Chikhalthana MIDC, Aurangabad Pin - 431 006**, the Second Party is promoted by Self.
- G) Give related information, its branches, and dimensional information about the industry concerned with whom the MOU is sworn.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

Any act on the part of **SHODH ADVANTECH LLP, C-36/2, Chikhalthana MIDC, Aurangabad Pin - 431 006**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
