Item 3 - To organized Programme and workshop on women empowerment


Resolution - Considering the Item number 3 it is decided to organize programme on women empowerment and training of karate particularly on self defense.

Item 2- To considered the measures to be taken in to account for safety of women in the college campus.


Resolution: Considering the Item no.2 the following matters were included as per government resolution in the college premises about the safety of women.

- 3) The above suggestions is being approved in the meeting.


Item 3 – To organize one day awareness workshop on prevention of sexual harassment of women at work place Act 2013 under W.G.R. Committee.

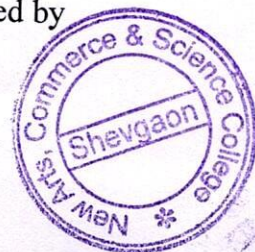
